

RESOLUTION UPON THE DEATH  
OF  
Charles P. "Pete" Wasovich

WHEREAS, The Almighty has called to His eternal reward one of our brothers, Mr. Charles P. "Pete" Wasovich, a practicing attorney, who died on February 12, 2009; and

WHEREAS, the Blair County Bar Association Board of Governors has called an assembly of the Blair County Bench and Bar in profound sorrow to make this memorial tribute to a fellow attorney; and

WHEREAS, the Committee designated by John E. Fleming, President of the Blair County Bar Association, respectfully submits the following Resolution upon the passing of Charles P. "Pete" Wasovich, whose death brought profound sorrow to all of those who knew him.

Charles P. "Pete" Wasovich was born January 3, 1948 in Rochester, Pennsylvania, a son of Peter and Joan Wasovich. Pete was a graduate of Aliquippa High School and graduated with a Bachelor of Arts in Political Science from Washington and Jefferson College, where he was a member of Kappa Sigma fraternity. He concluded his formal education upon the receipt of a law degree from the University of Toledo Law School in 1972. Pete was admitted to the Supreme Court of Pennsylvania on March 9, 1977. He was also admitted to the United States District Court for the Western District of Pennsylvania and the United States Court of Military Appeals.

He married Terry Crist on August 22, 1970 in Johnstown, Pennsylvania.

Pete served as an Army attorney in the Judge Advocate General's Corps from August 1973 to August 1977. His service in the U.S. Army Reserves began June 7, 1969 when he was commissioned as a second lieutenant. He rose to the rank of Lieutenant Colonel. As commander of the 42<sup>nd</sup> Judge Advocate General's Detachment from July 1, 1987 to September 18, 1993, he received the meritorious service medal.

Pete spent his Blair County law career in the Law Firm of Goodman, Notopoulos, Silverman, Wasovich and Mears, becoming a partner in 1982. He also served as an assistant District Attorney for Blair County for the last three decades, the last fourteen years in charge of juvenile cases. He served in the House of Delegates of the PA Bar Association, and was a member of the National DA Association, the United States Army Judge Advocates Association

and Phi Alpha Delta Legal Fraternity.

In his spare time, he enjoyed coaching youth sports -- namely football, basketball and baseball, his weekend car washes, walking his dog, and spending time with his family.

Pete was well known for his keen wit and dry sense of humor. He could always be counted on to lighten things with his one-line quips and his endless stories.

He is survived by his wife Terry; two sons, Jason and wife, Kiersten and Jonathan; and a sister, Sandra Wasovich. Charles P. "Pete" Wasovich, Esquire will be missed by all who knew and loved him.


We cannot understand the brevity of life's span and words are wholly inadequate to express our deep sense of loss at his passing.




