IN RE: ALL CONTINUANCE REQUESTS, EXCEPT FOR DOMESTIC AND JUVENILE OFFICES

In order to alleviate any confusion and/or duplication in the processing of continuance forms the following policies have been adopted:

- 1) Continuances by Fax (Facsimile) will only be processed if they are for proceedings scheduled within 10 days of the date submitted.
- 2) Continuances accepted and processed by Fax (Facsimile) do not require the filing of the original continuance.
- 3) Original continuances, except for custody, are to be filed in the District Court Administrator's Office during regular business hours.
- 4) Original continuances for custody cases are to be filed in the Custody Office between the hours of 8:30 – 11:00 AM and 1:00 – 3:00 PM.
- 5) Continuances for Domestic Relations and Juvenile Divisions are to be filed in the appropriate offices according to their respective policies.
- 6) At **no time** are continuances to be filed, copied or faxed to any Judges' Chambers
